President's Message

This year, the Asian Institute for Distance Education Foundation Inc. celebrates its 35th Founding Anniversary. As a distance education institution, it has endeavored to provide quality higher education programs during the past years. It has provided wider and more flexible means of education to working students and professionals.

As a non-profit open school, our operation has become unprecedented, fruitful and meaningful especially that we were able to help professionalized the manpower complement of some government institutions and corporations. For one, we were able to graduate policemen who were not able to finished college. In 2002, we forged an agreement with the Philippine National Police (PNP) to help police officers obtain a college degree. Hence, more than one hundred policemen graduated from AIDE. Secondly, we were likewise able to graduate significant number of government employees from the Philippine Amusement and Gaming Corporation (PAGCOR). Lastly, since the beginning of our operations in the early 80's we were able to enroll sizable number of Overseas Filipino Workers (OFWs) who already graduated and became college degrees holders. Currently, more than 10% of our student population are from these sphere.

As we continue to make education more accessible to the many Filipinos, we will continue to improve our mode of non-conventional delivery. In fact, recently, we have employed ICT enabled teaching-learning facilities to supplement our existing print-based materials and delivery; this includes the use of Learner Management System (LMS) powered by NEO Cypher Learning and use of educational videos and facilitator-led instructions.

Also, we have updated and rewritten our modules by hiring competent Professors from known Universities to write the new content that is in conformity with the new CHED policies, standards and guidelines (PSGs).

As we continue to operate as a quality distance education provider, we will remain committed to our goal of providing a second chance, to every sector of our society, to acquire a college degree which has gone beyond their reach because of family responsibilities, illness, financial hardship, or space/time constraint.

At AIDE, we do recognize that millions enroll in formal schools every year. Many millions more cannot. It is the vision of AIDE, that for those who cannot go to the University, we shall bring the university to them.

AIDE's Mission


To provide quality higher education to persons, who, because of time, space, work, physical or medical reasons, cannot avail themselves of regular schooling.


AIDE's Objectives

- 2. To provide continuing development-oriented study programs for public and private office personnel as well as for the general public.









AIDE'S CONCEPTION STAGE

AIDE was formally recognized as an education institution on April 11, 1984. But the concept of the Asian Institute for Distance Education (AIDE) really began as early as 1981 when Filipinas Foundation, Inc. embarked on a project to help the Philippine Foundation for Independent Study, Inc. (PFIS) raise funds in order to set up an educational institution which would utilize the non-formal system of instruction.

AIDE'S HISTORY

EFFORTS TO BE A CHARTERED INSTITUTION



Dr. Victor M. Ordoñez was at various times, Dean, Interim President, or Board Chairman of several colleges and universities, Undersecretary of the Department of Education, and Chair of the Presidential Commission for Education Reform. He became a Senior Education Fellow at the East West Center, where he started the "International Forum for Education 2020", aimed at fostering new paradigms for the future.

Based on a study done by Dr. Victor M. Ordonez (Former Undersecretary of DECS and Director for Basic Education Division - UNESCO), the project to set up an educational institution which would utilize the non-formal system of instruction required legislation to grant a charter to what was to be known as the **Asian University for Independent Study (AUIS)**. Parliamentary Bill No. 1033, which sought to establish the AUIS project, was introduced in the 1982 session of the Batasang Pambansa. Since the bill went no further than the first reading, the project was soon abandoned.

THE FOUNDING OF AIDE

A year later, on June 1983, the project was reactivated when Filipinas Foundation, Inc. Director, Rogelio S. Pantaleon (Former Vice President of Ayala Corp. and Managing Director of Makati Business Club), requested Dr. Antonio Orendain, Dean of Graduate Studies of the Far Eastern University (among the founding officers of the NCR School Registrar's Association (NSRA) and author of various books on Parliamentary Rules and Procedure), to react to the Ordonez AUIS Feasibility Study and Parliamentary Bill No. 1033.

Dr. Orendain consequently proposed that the bill be disregarded and that Filipinas Foundation should proceed to establish the school under the provisions of existing rules and regulations on accrediting institutions utilizing the non-formal delivery system. The decision to act on this proposal initiated preparations for the establishment and organization of the school. With its name slightly altered – from Asian University for Independent study to Asian University for Independent Study to Asian Institute for Distance Education – thus was AIDE born.

MAPPING OUT OF AIDE'S CURRICULA

By august 21, 1983, the initial academic curricula and the administrative system of the school were mapped out by Dr. Orendain together with Dr. Concesa Baduel, Assistant Director of the Bureau of Higher Education Division of the Ministry of Education, Culture and Sports (MECS), and Dr. Felicidad Robles, Chairman of the FEU English Department. Later to join the group as consultant was Dr. Narciso Robles, Dean of the Graduate School of the University of Pangasinan.

FORMAL RECOGNITION OF AIDE AS A HIGHER EDUCATION INSTITUTION (HEI) BY THE MINISTRY OF EDUCATION, CULTURE AND SPORTS (MECS)

On April 11, 1984, AIDE was formally recognized as an educational institution when it was granted a permit to open and conduct a two-year course leading to the degree of Associate in arts, and a four-year general course leading to the degree of Bachelor of Arts. A year later, on July 11, 1985, both courses were granted recognition by the MECS.

AIDE'S HISTORY

MECS GRANTED AIDE THE PERMIT TO OFFER BUSINESS ADMINISTRATION

On February 11,1985, the MECS, National Capital Region, granted AIDE a permit to offer the four-year course in Business Administration, major in Management; recognition for this course was subsequently granted in January 6, 1986.

THE OFFERING OF PORT ADMINISTRATION PROGRAMS

In 1986, AIDE initiated new and non-traditional programs with the offering of three Ports Education Programs; namely, the two-year courses leading to the titles of Associate in Port Management and Associate in Port Equipment Operation, and the four-year course leading to the degree of Bachelor of Port Administration, while maintaining as its basic academic-technical courses of a totally new and dynamic student population.



Legal Basis of Distance Education in the Philippines




In today's globalization and rapid technological advancements, dramatic changes have been happening in higher education, e.g. the dearth of resources for classroom-based instruction, the development of the open and distance learning philosophy, the need to service the needs of adult learners and many other factors which are the reality in the Philippines today. As a consequence, higher education institutions have been increasingly flexible to adjust their delivery system in an effort to respond to these changes. Distance Education (DE) has emerged as a legitimate alternative learning system (ALS) to the more traditional educational system in a number of higher education institution (HEIs) in the Philippines.

Under the 1987 Philippine Constitution, Article XIV mandates that quality education at every level should be made accessible to all Filipinos, including self-learning, independent, and out-of-school youth programs. Thus, the Open University systems and distance education ideology has proliferated in the Philippines over recent years especially in the last two (2) decades. This is considered as one of the most rapidly growing fields and means of education; such that it changes the approaches used; the delivery system; faculty requirements; and the need to respond to the rare breed of students which are being catered to by this type of educational arrangement. The 1987 Constitution

The legal basis of distance education in the Philippines started with the writing of the 1987 Philippine Constitution. This is even before the CHED was founded. Hence, even before all laws and CHED Memorandum Orders governing the practice of distance education in the country were written, AIDE has already thought of widening the Filipino's reach to quality higher education courses via distance education when it initially proposed to Congress the putting up of the Asian University of Independent Study (AIUS) in 1982 and the subsequent establishment and operation of the Asian Institute of Distance Education (AIDE) in 1984. While AIDE started its operation even before all laws and policies on distance education (DE) and open learning (OL) system have been issued, we deem it appropriate to present the following legal basis that guides the practice and operation of DE/OL, to wit:

1. Section 1, Article XIV, 1987 Philippine Constitution

Section 1, Article XIV specifically provides that: "the state shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make education accessible to all."

2. Section 2, Article XIV, 1987 Philippine Constitution

The state shall established, maintain, and support a complete, adequate, and integrated system of education relevant to the needs of the people and society; and that the **State shall encourage non-formal**, informal and indigenous learnings, as well as **self-learning**, **independent**, **and out-of-school student programs** particularly those that respond to the community needs.

CHED Memorandum Order (CMOs)

1. CHED Memo 27 s. 1995

POLICIES AND GUIDELINES ON DISTANCE EDUCATION

Section 2. of CMO 27 defines Philippine Distance Education as: "A program is said to be offered on Distance Education mode if at least half of the total number of hours required for degree program is offered outside of the confines of the formal classroom set-up where student-teacher contact is normally required. Distance education may be delivered using printed instructional materials, video, radio or teleconferencing with sufficient provisions for valid and reliable and evaluation procedures.

In accordance with the pertinent provisions of Republic Act (RA) No. 7722, otherwise known as the "Higher Education Act of 1994", per Resolution No. 204-2000, and for the purpose of rationalizing Open Learning and Distance Education (OL/DE) in the country, the following updated policies and guidelines on open learning and distance education are hereby adopted and promulgated by the Commission. Thus:



2. CHED Memo 35 s. 2000 - UPDATED POLICIES AND GUIDELINES ON OPEN LEARNING AND DISTANCE EDUCATION

Section 3 - 5 of the said CMO specifies that CHED, in pursuance of Section 1 and 2, Article XIV of the 1987 Philippine Constitution shall:

- ⇒ Takes cognizance of the need to make quality education accessible to a greater number of qualified Filipinos.
- ⇒ Recognizes that education and acquisition of higher learning take place both within and beyond the confines of classrooms.
- ⇒ Recognizes that non-formal and informal learning systems complement the formal system.

Among the salient features of CMO 35 s. 2000 is the following definition:

OPEN LEARNING AND DISTANCE EDUCATION (OL/DE) are alternative systems of education. They emphasize the opening of opportunities by overcoming barriers that result from geographical isolation , personal or work commitments or conventional course structures which have often prevented people from realizing their educational goals.

OPEN LEARNING (OL) is a philosophy of learning that is learner-centered and flexible, enabling learners to learn at the time, place and pace which satisfies their circumstances and requirements.

DISTANCE EDUCATION (DE) is a mode of educational delivery whereby teacher and learner are separated in time and space and instruction is delivered through specially designed materials and methods and supported by organizational and administrative structures and arrangements .

AIDE TO RETAIN ITS RECOGNITION

Article V (Transitory Provision), Section 17 of CMO 35 s. 2000 provides that:

"HEIs operating OL/DE programs whose recognition was granted by the DECS prior to the creation of CHED and CHED Order No. 27. s. 1995 **shall retain their recognition**."

AN ACT EXPANDING ACCESS TO EDUCATIONAL SERVICES
BY INSTITUTIONALIZING OPEN DISTANCE LEARNING
IN LEVELS OF TERTIARY EDUCATION AND
APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Short Title. - This Act shall be known as the "Open Distance Learning Act".

SEC. 2. Declaration of Policy. – It is hereby declared the policy of the State to expand and further democratize access to quality tertiary education through the promotion and application of open learning as a philosophy of access to educational services, and the use of distance education as an appropriate, efficient and effective system of delivering quality higher and technical educational services in the country.
